1. Rules and Regulations

This Agreement and the use of the interment space are subject to the Rules and Regulations of the Cemetery now existing, and as hereafter adopted or changed. A copy of such Rules and Regulations is available in Catholic Cemeteries' office at the address stated on the front side hereof. Such Rules and Regulations include, but are not limited to, the following requirements and restrictions:

(a) Owner(s) of the right of interment or entombment will be allowed to inter or entomb only members of their families or those they so designate in the graves or crypts. Although the Cemetery is intended for members of the Roman Catholic Church, nevertheless, Catholic Cemeteries, not wishing to separate in death those who were united in life, permits a non-Catholic relative to be interred or entombed in the Cemetery. No person shall be interred in such grave or plot who is not entitled to burial in Catholic Cemeteries under the laws and discipline of the Roman Catholic Church, as administered and determined by the Ordinary of the Roman Catholic Diocese of Sacramento.

(b) Arrangements for burial must be made at the Cemetery office by the immediate relatives of the deceased at least 24 hours before the time of interment.

(c) No interments shall be permitted on Sundays or holidays when the Cemetery office is closed.

(d) In the event of inclement weather, Catholic Cemeteries reserves the right to postpone interment until improved weather conditions permit.

(e) All interments, disinterments, and removals, including all openings and closing of graves and mausoleum entombments shall be made only by the Cemetery with its own personnel and equipment.

(f) After interment, no body shall be removed from the Cemetery without the consent of the Director of Catholic Cemeteries.

(g) No memorial will be permitted on any grave or crypt until the Benefactor's account for purchases of services and merchandise made herein has been paid in full. Prior to purchasing a memorial, Benefactor should ascertain the rules pertaining to same. Catholic Cemeteries will not be responsible for memorials purchased by Benefactor that do not conform with the Cemetery's Rules and Regulations. All improvements are subject to the inspection and approval of the manager of the Cemetery. Contracts and tracings of proposed monuments must be submitted to the manager of the Cemetery and no work shall begin until

approved. No monuments extending above the surface of the ground shall be erected on

a grave "unless permitted in a zone specifically designated for standing monuments." Monuments must be either granite or bronze and the design and inscription must be approved by the manager. Cemetery authorities, at the expense of the plot owner, may remove any monument that is improper or that has become dangerous or dilapidated, upon sending of a notice to that effect to the last known address of the Bene factor.

(h) Cemetery management reserves the right to do all planting of trees, shrubs, and plants. No person shall plant or place trees, shrubs or other embellishments of any kind upon the graves. Cemetery authorities reserve the right to remove all trees, shrubs and embellishments, which are unsightly, dangerous or impede the process of care.

(i) No person may visit the mausoleum or garden crypts except during regular visiting hours which are between 9:00 a.m. to 4:00 p.m., but which may be changed from time to time by the Director of Catholic Cemeteries without notice. No person may visit the Cemetery except during regular visiting hours which are between 8:00 a.m. and 5:00 p.m., but which may be changed from time to time by the Director of Catholic Cemeteries without notice.

(j) Cemetery, upon receipt of the Aggregate Amount, together with other incidental charges, if any, agrees to execute and deliver, or cause to be delivered a Certificate or Right of Interment evidencing ownership of burial rights.

(k) The Cemetery regulates the use of fresh cut and artificial flowers for placement at graves, niches, and crypts; any non-complaint item may be promptly removed and discarded. Decorations are generally removed weekly with the specific day posted at the Cemetery. Any seasonal exception to this rule will be posted in the Cemetery office. The planting of flowers, shrubs, trees or plants of any kind on any grave will not be permitted. The vases installed by the Cemetery's management are the only items permitted.

(l) Families wishing to keep any items delivered for the funeral service must pick them up after the committal service. Funeral flowers will be removed by the Cemetery following the interment.

(m) Catholic Cemeteries shall have no responsibility for loss of damage to memorial or flower containers. Catholic Cemeteries shall not be liable for damage to or destruction of the interment space except to the extent that such damage or destruction is caused by Catholic Cemeteries' willful misconduct or gross negligence.

(n) The cemeteries (including the Cemetery) operated by the Catholic Cemeteries Department are private properties open to the public for set hours daily, 365 days per year. In the interest of protecting families, families should not place any item of value on a grave, niche or crypt. Catholic Cemeteries shall not accept responsibility or liability for the disappearance, loss or damage to any such items. In the case of glass front niches, Catholic Cemeteries has not responsibility or liability for loss or damage to valuables (sentimental or specific value) that are placed inside of the glass front niches.

(o) The Benefactor hereby releases Catholic Cemeteries and its affiliates, employees, agents and representatives from any liability for the loss or damage to items placed outside or inside graves, niches or crypts. Catholic Cemeteries is not liable for any damage to any property as a result of an act of God or malicious mischief or for any other occurrence where Cemetery has exercised reasonable care.
